

#### 1. Manipur Situation

#### **Background**

Manipur is a small state in India, situated on the border with Burma/Myanmar. It has a total area of 8,621 square miles, with a valley region covering 700 square miles, and the rest of the area is the surrounding hill ranges. The valley (erstwhile Kangleipak) is inhabited primarily by the majority Meitei community. The capital city of Imphal is located in the valley. Minority tribes predominantly occupy the hill areas, including the Naga and Kuki-Zomi communities. Historically, the Meitei did not have permanent settlements or authority over the tribal communities in the hills.

During the British colonial period, Manipur had separate administrations for the valley and the hills. British officers oversaw the management of the hill areas, while the Maharaja of Kangleipak ruled over the valley under British suzerainty. Following India's independence and the eventual attainment of statehood by Manipur in 1972, special provisions were implemented to safeguard tribal land rights in the hills under Article 371C of the Indian Constitution. This included the establishment of administrative bodies such as the Hill Areas Committee (HAC) and the District Councils (DCs) to protect the interests of the tribal communities.



#### The Trigger

A directive issued by Judge M V Muralidaran of the Manipur High Court on April 19, 2023, recommending the inclusion of Meitei in the Scheduled Tribe (ST) list of the Indian Constitution is a trigger for the current crisis. The directive raised concerns among the minority tribes in the hills as it could result in the loss of their ancestral land rights to the Meitei. The All Tribal Students Union Manipur (ATSUM) organized a peaceful protest rally on May 3, 2023. However,

the Meitei Leepun, representing the Meitei majority, opposed the rally and initiated a blockade on May 2<sup>nd</sup>, which hindered the movement of people. On May 17<sup>th</sup>, the Supreme Court of India declared that the order made by the Manipur High Court was outside the purview of the High Court. However, the damage had already been done. Subsequent violence and destruction already resulted in the separation of the Kuki-Zomi people from the valley and Meitei from the hills.

#### The Destruction

On May 3<sup>rd</sup>, 2023, toward the end of the peaceful protest in the hill districts, rally goers got news of unidentified Meitei miscreants desecrating the Anglo-Kuki War (1917-1919) Centenary Gate at Leisang-Monglenphai. Witnesses also reported that a throng of Meitei miscreants from the adjacent town of Moirang entered Torbung and Kangvai and set Kuki tribal houses on fire. The situation escalated further when Pastor Sehkhohao Kipgen, who was returning from the rally, was fatally attacked by radical Meitei groups. Within hours after the first Kuki victim was murdered and his village torched, radical Meitei mobs executed systemic arson and murder in Imphal, the capital city [1]. Churches, homes, cars were burnt to ashes in a matter of hours. This was possible because the Meitei had identified and marked Kuki-Zomi homes through bogus surveys since January 2023. The Kuki-Zomi settlements were marked in Google Maps and circulated among the Meitei.

A significant number of fatalities among tribal individuals remain unreported as families cannot access the morgues at Imphal hospitals. In the presence of Meitei mobs patrolling the streets of Imphal, retrieving deceased family members poses a grave risk to the lives of tribals. Many are officially listed as missing, with little hope for their safe return. No one from the minority tribes was spared, not even women, children, ministers or government officials. For instance, Vungzagin Valte, a Kuki-Zomi BJP Member of the Legislative Assembly (MLA) and an adviser to the Chief Minister on tribal affairs was beaten and left for dead. He currently lies in critical condition in Delhi, while his tribal driver lost his life during the attacks, as mentioned earlier.

In the first few days, more than 16,000 tribals sought refuge in various military camps to escape the ongoing turmoil. However, as the number of shelter seekers grew daily, it posed a challenge for the military to provide sufficient protection and necessary provisions.

#### **Ongoing Onslaught**

Since May 3<sup>rd</sup>, 2023, Kuki-Zomi villages have faced relentless attacks by radical Meitei groups Arambai Tenggol and Meitei Leepun. The perpetrators of these heinous crimes, often masquerading as security forces, are openly escorted by State Security forces. Chief Minister Biren Singh, who is a Meitei, began categorizing tribal villagers as militants and terrorists. Consequently, Manipur state forces composed of Meitei police and commandos, attacked tribal villages. The Internet had been banned since May 4<sup>th</sup> except in certain Imphal areas. The entire media in the state is owned and controlled by stakeholders from the Meitei community. TV cable networks, news reports, newspapers, reporters, and anchors serve, and represent the opinions, experiences, and perspectives of the Meitei community. They distort and manipulate events, spread misinformation and propaganda to reinforce the fraudulent notion that Kuki-Zomi people defending their villages are "narco-terrorists" and "militants" even when General Anil Chauhan, the Chief of Defense Staff of the Indian Army has categorically stated that the ongoing conflict

in Manipur is not a "counter-insurgency" issue but "a clash between two communities" [2]. Further, neutral, third-party journalists from outside have faced harassment and death threats from the Meitei community for reporting a gunfight between 37 Assam Rifles and the radicalized Arambai Tenggol militia [3].

The Kuki-Zomi villages are compelled to defend themselves and have resorted to using licensed shotguns and improvised weapons. However, they are no match to the Meitei attackers equipped with looted automatic assault rifles and mortars from police armories in Imphal. There are reports by Indian army officers on the ground that these looted weapons were not stolen but rather "handed over" [4]. These attacks on Kuki-Zomi villages indicate a targeted campaign against the community, raising fears of ethnic cleansing. Tribal lands border Myanmar, and by driving Kuki-Zomi from their ancestral lands, the Meitei could gain control of the international trade corridor that would expand under the Look East Policy of the current central government. This situation exposes a disturbing complicity between Meitei radical groups and the state machinery [5].

Tribal people from the valley and peripheral villages have been forced to leave their homes and reside in various temporary shelters and relief camps. These camps are managed and sustained by local tribal public and philanthropic organizations, as they have received no assistance from the Manipur government.

Following four weeks of persistent violence, the Indian Home Minister, Amit Shah, visited Manipur and appealed for peace for 15 days. Disturbingly, attacks against the Kuki-Zomi community have escalated with enhanced support from state security forces [5,7]. Multiple instances of the state's involvement in viciously targeting minority tribes have been documented, including using state security's armored vehicles.

This conflict can be characterized as a war instigated by the majority population, which constitutes 53% of the total population, against the Kuki-Zomi minority tribe, representing 16% of the population. Additionally, religious divisions have emerged, pitting Hindus against Christians. Among the 317 churches targeted and destroyed, 170 belonged to the Meitei Christian community. Since the official 2011 Census, there has been a noticeable shift in the religious demographics of Manipur. Hinduism remains the predominant religion in the state, followed closely by Christianity, Islam, and other faiths [8]. The increased Christian population has caused dissatisfaction among groups like Meitei Leepun and Arambai Tenggol [5].

The Meitei radical groups involved in the conflict have carried out horrific acts, including immolating a seven-year-old child Tongsing Hangshing, his mother, and a friend while traveling in an ambulance to the Imphal hospital. What is most disturbing about Tongsing Hangsing's murder was that it was not just militants but mobs of ordinary Meitei women and men who committed the atrocities [6].

#### Recommendation

Why has the central government been unable to maintain law and order in Manipur and allow the continued aggressions and unprovoked attacks on Kuki-Zomi tribes? How many lives must be lost before Prime Minister Modi speaks out and addresses the ongoing carnage? The lack of

response or action from the central government implies the tacit approval of the atrocities committed against minority Kuki-Zomi that are predominantly Christians.

The fact that attacks have continued for over a month is evidence of the State Government's failure to maintain law and order. How long will America and international human rights organizations remain mute spectators of the Government of India's apathy towards the civilians and displaced people in Manipur? We request stakeholders in positions of authority and power to seek accountability for the Modi Government's silence on the carnage against the Kuki-Zomi people. Given the state government's involvement in the acts of violence, we request the promulgation of the President's Rule in Manipur before a long-lasting political solution and peacebuilding interventions can be established. This way, trust between the affected communities can be restored, and rehabilitation processes can be initiated. We request a non-partisan inquiry, such as UN intervention, to bring about a democratic, constitutional, and sustainable solution in the form of a separate administration for the Kuki-Zomi.

There are 101 confirmed dead among the Zomi-Kuki population, hundreds unconfirmed injured and missing, 35,000+ displaced, and 317 churches desecrated and razed. These numbers will continue to rise until an international body such as the UN or countries, such as the US, committed to human rights and justice, intervene to promote peace and stability in Manipur.

#### 2. State Assembly

Out of the total 60 seats in the Manipur State Legislative Assembly, tribals have 20 seats despite tribals accounting for more than 40% of the total population. As a result, the tribals of Manipur cannot play a substantial role in the decision-making process in the State. As per the 2011 census, each of the tribal MLAs from the Hill areas of Manipur represents 1004.45 sq. km. and 55,107 persons each, while their counterparts in the Imphal valley represent 56 sq. km. and 43,294 persons, respectively.

With this skewed representation at the state assembly, the District Council has no legislative or judicial power. *At best, it enjoys recommending power*. The provision of the Council is susceptible to interference by the Manipur government through amendments.

#### 3. Systematic Marginalization of Tribal

Without the Sixth Schedule, Tribal Right to autonomous administration in Manipur has not been promulgated since Hill tribes became part of Manipur. The Sixth Schedule is an Indian constitution provision to the Administration of Tribal Areas in North Eastern states of India except Manipur. The Hill Areas Committee officially demanded the extension of the Sixth Schedule to the Hills Areas of Manipur in 1974 but has always been rejected by the Meiteidominated State-government. The demand was reiterated in 1978, 1983, 1990, 2002 and 2003. Although the State Cabinet recommended extending the Sixth Schedule provision in Hill areas of the State on three occasions, i.e., 1991, 1992 and 2001, they shrewdly added the statement, "with certain local adjustment and amendment," but Sixth Schedule has not been promulgated.

#### 4. Budget Allotment Inequity

There is an inequitable allocation of funds for developmental works in the Hills and Valleys. Many villages in the hills lack basic health care services, water supply and electricity. The State government discontinued preparing a separate Hill Budget in the 1980s without any explanation. Although 90 % of the State is hill areas, the budgetary allocation for developing the hill areas never crossed 10 % of the State's budget. Moreover, the Grant-in-Aid (Art. 275) received for the development of the hill areas is diverted for the development of valley areas. *Source: Alfred Arthur, Ex-MLA 44 ST assembly constituency*

#### 5. Development Inequity

The often-repeated claim that the Imphal Valley is becoming more congested is due to the ever-increasing concentration of government infrastructures within the confines of Imphal Valley. The Hill Districts remain grossly neglected in terms of development and funding. All the important government offices and all eminent educational, technical and medical institutions are exclusively concentrated in the Imphal valley. Some examples include the Central Agricultural University (CAU), Central Institute of Plastics Engineering and Technology (CIPET), Manipur University (MU), Regional Institute of Medical Sciences (RIMS), Jawaharlal Nehru Institute of Medical Sciences (JNIMS), National Institute of Technology (NIT), Manipur Institute of Technology (MIT), Institute of Bioresources and Sustainable Development (IBSD), Takyelpat, Manipur Technical University, National Sports Academy Khuman Lampak, National Sports University, Sports Authority of India, among others [1].

#### 6. Tribal Land Encroachment

The State government headed by Chief Minister N Biren Singh had declared Reserved Forest, Protected Forest, Wildlife Sanctuaries, National Parks, and Wetlands over most tribal lands without consulting the tribal land-owners. This move by the Biren Singh government can be argued as an unconstitutional procedural lapse. Under the direction of the Manipur government, an eviction drive was carried out on February 20, 2023, at K Songjang village. The Manipur government claimed that the village was newly set up in 2021. The sparsely populated village was among the many villages destroyed in the violence of the Kuki-Naga clashes in 1993.

The proposed Churachandpur-Khoupum protected forest, issued in November 2022, is a special order which set aside previous orders that excluded villages from the proposed protected forest area in the 1970s and early 1980s. With this new order, 38 villages in Churachandpur became encroachers overnight. In April 2023, there were attempts by the forest and revenue departments to conduct a joint survey in the disputed protected forest. The Indigenous Tribal Leaders' Forum (ITLF) opposed the joint survey and pointed out that the consent of affected villages was not taken and due process was not followed. If all the proposed Reserved Forests, Protected Forests, Wildlife Sanctuaries and other declarations are implemented, the tribals will have less than 10% of their present area for their habitation and livelihood [1].

#### 7. Revisionist History

#### **Bogus Myths**

The State government recently invoked mythical Meitei icons and Meitei gods to transform tribal lands into archaeological sites. Take the case of Koubru, which was proclaimed as Laipham or the seat of the Meitei god Lainingthou and the case of Chivu (near Behiang), where allegedly footprints of Meitei Maharaja Chandrakiri were found, were invoked to usurp tribal land, rename and built commemorative and religious structures. In both cases, the indigenous tribal narratives and the sacredness of these places to the tribals were completely ignored [1].


Until recently, these tribal forests and hills were foreign to the Meitei and the State government. However, the strategic importance of these border areas under the present Central government's **Act East Policy** and its possible significance for thriving long-term trade has driven the imposition of majoritarian culture upon these hill areas. The Meitei Maharaja had never set foot in these Hills; the recent attempts to claim ownership using the State apparatus are a grave affront to tribals' land rights and culture. Despite widespread public opposition, the communal land-grabbing project at Chivu called Chandrakirti Park was pushed as an intermediary to development in those parts of the Hills. Furthermore, the claim to those places was rationalized in the media via a distorted interpretation of historical data and records of the Lushai Expedition and prior.

#### **Distorting Tribal history**

Chief Minister N Biren Singh has openly accused the Zo people (Zomi-Kuki-Mizo-Hmar) as "foreigners" or "illegal immigrants," inciting communal hatred and violence in the process. The tribal communities occupied most present-day settlements, administering their affairs long before the British arrived. In James Johnson's 1896 book, "Manipur and the Naga Hills," the present-day districts of Manipur (now Churachandpur and Pherzawl districts) were not within Manipur, rather they were part of the Lushai and Chin Hills until 1894 [9].

It was after the annexation of Manipur by the British colonizers in 1891 that the British Government set up the Manipur-Chin Boundary Commission in 1894. After the Kuki uprising (locally known as Zo-Gal) of 1917-1919 [11], the hill areas were annexed and brought into the fold of Manipur and became a political entity with Manipur. The Zo people are proud citizens of

India and patriots who have contributed not only towards its freedom movement (Kuki-Zomi freedom fighters in INA) and its independence in the past but also its nation-building in almost every field in the present [12].



#### Labeling of Zomi-Kuki as poppy planters

The arbitrary and baseless branding of the Zomi-Kuki tribes as 'poppy cultivators' and 'narcoterrorists' is part of a malicious design to confiscate tribal lands. Chief Minister Biren Singh and his team have used this concocted narrative to openly state that the village chiefs on whose land poppy cultivation is undertaken will be held accountable, and *the village will be derecognized*. He further mentioned that the Manipur government would take ownership of historically tribal lands. The Narcotic & Affairs of Border website of Manipur Police has said the majority of the opium manufacturing laboratories are in the Manipur Valley. The largest drug kingpin in the State is linked to one of the chief Minister's most-trusted cabinet ministers.

#### 8. Arambai Tenggol and Meitei Leepun Militants

Arambai Tenggol and Meitei Leepun are the two organizations that witnesses identified as the perpetrators of the violence against Kuki-Zomi and Meitei Christian Churches. They are helped by the state security forces (Commandos) and patronized by Chief Minister Biren Singh. Per the scroll article [5], the titular king, Sanajaoba, a Rajya Sabha member nominated by BJP, is the founder and leader of Arambai Tenggol. Arambai Tenggol means "dart-wielding cavalry," a reference to traditional Meitei warriors. They are easily recognizable due to the three pony-riding warriors embossed on the back of the outfit's uniform of black T-shirts. On September 25, 2022, Sanajaoba posted pictures of the oath-taking ceremony of the group at his house. The outfit's only motive, according to Bobo Moirangthem, was to bring Meiteis back to the fold of

Sanamahism. "Most of the Meiteis are converting to Christianity, so we just want to bring people back," he said [5].

The demand for Scheduled Tribe status is inextricably linked to the tenets of Sanamahism, where the Meitei communities were divided into seven clans called Salai Taret - Mangang, Luwang, Khuman, Angom, Moirang, Kha-Nganba & Salang-Leishangthem. The seven clans, they claimed, are the tribal identities of the Meiteis. Insecurity about Christianity was a common concern for the Arambai Tenggol and the Meitei Leepun, the other valley-based outfit accused of fanning violence against Kukis. Arambai Tenggol hoists and flies the Salai Taret flag at every village and church they burn and destroy.

Pramot Singh, the founder and leader of Meetei Leepun, said in the scroll interview, "Only with a strong Meitei population, a strong Hindu population can India be a strong nation." In his interview at "The Wire" with Karan Thapar on June 6<sup>th</sup>, Premat Singh spoke of imminent genocide and threatened to bomb Kangpokpi town (15 km square of Kuki settlement) at timestamp 1:03:45 [10]. He speaks with impunity because the government protects him.

#### 9. Removal of Armed Forces Special Powers Act (AFSPA)

AFSPA, the Act, which gives sweeping powers to the armed forces, was removed from six districts in Imphal in April 2022. The Act was further removed from Wangoi, Leimakhong, Nambol and Moirang parts of Valley districts in March 2023 but not in the hill/tribal areas of Manipur [13].

#### 10. Gun license removal/renewal in Lamka

On February 14, 2023, while gun licenses in the Hills were forced to be renewed and guns surrendered, the Manipur government issued more than a thousand gun licenses in the Imphal Valley.

#### 11. Bogus Survey

The houses of the Kuki-Zomi people were either marked with paint or numbered in Imphal from January 2023. Door-to-door surveys of houses were held in mixed neighborhoods to identify tribal homes, churches, hostels, educational institutions, and even paying guests rented homes months before the ethnic cleansing through official and unofficial means; this allowed the organized mobs to immediately identify all tribal residences in a matter of hours and destroy all tribal homes, properties, and places of worship without any hindrance.

#### 12. Human Rights Violations

These incidents have resulted in grave human rights violations, encompassing the right to reside in one's ancestral homeland, freedom of religion and belief, the right to life, physical integrity, freedom of movement and residence, the right to security, and the prohibition of torture and inhumane treatment. The relentless attacks continue daily, and the list of casualties continues to grow.

Description: Twenty-year-old Jamngaihkim Gangte's life has altered over the past four weeks. A college student in Imphal, her mother, a government servant, and her brother were murdered during the violence in the state.

Jamngaihkim witnessed their deaths, she said. She then fled to Delhi, where she spoke to Newslaundry's Shivnarayan Rajpurohit about what she went through from the evening of May 3. Over the course of 24 hours, she said, she and her family were chased by vindictive mobs, grilled for their ethnic identity, and compelled to lock themselves in a building's terrace room for five hours before squeezing into a car's boot to safety. By the end of this ordeal, they would witness unparalleled loss with the killing of Jamngaihkim's mother and brother.

"They did not spare any of us," she said. "They hit us any way they could."
